

# Light Voter Turnout in Primary; Heemstra Keeps Cascade Post

Voters turned out in light numbers to vote in Tuesday's primary election.

The results of the local contests produced few surprises.

Most of the notoriety was on the race for the supervisorship in Cascade Township where incumbent Al Heemstra was pitted against Louis P. VanDer Berge. Heemstra easily won reelection.

Heemstra, obviously elated by his win, told his supporters:

"I express my appreciation for those who supported me and pledge every effort to conduct the township's affairs in the interest of all the people.

"Looking ahead for the next two years, I see a whole series of extremely important decisions to be made.

"We must accomodate the continuing pattern of growth since we are without our chosing the number one area of growth in western Michigan - both residentially and industrially. We'd like to take a balanced attitude with balanced growth."

"I especially want to try by every means possible to me to recapture respect for local government. I solicit the support of everyone who feels my goals are worthy. And," Heemstra added, "I want to show the same face to every man."

3 lb. gound veal, pork and beef (it's probably available at your supermarket meat counter or ask your butcher)

3 eggs 1 medium sized onion 3 T water 3 T catsup (4 capfulls) 2 T mustard 1 T Adolph's meat tenderizer ½ c well smashed crackers 1/ c milk (white) Ac'cent with garlic flavoring-about 10 good shakes Lowrey's seasoned pepper to taste. Hickory smoked salt to taste. 12 large hamburger rolls.

1. Give your wife the keys to the car . and send her off to visit her mother.

2. Once you've assembled everything, peel and finely dice the onion, and, to get the tears out of your eyes, repair to the patio to prepare the fire. Once the coals are lit, place the grill about 5 inches from them and return to the kitchen and mix yourself a drink-after you've washed your hands.

3. Everything goes into your wife's largest mixing bowl (on top of the meat)everything except the egg shells, rolls and your drink, that is.

4. Stick your fingers into the middle of what's in the bowl and start mixing. It gets to feel kind of nice after a while. When you feel everything getting too slippery (and/or sticky), run your fingers under the warm water tap for 1 minute or so.

5. Once everything is thoroughly mixed, form the mixture into the size and shape of a baseball (as opposed to a softball)

6. Before placing the meat on a wax paper-covered cookie sheet, clap your hands three or four times (but not enough to make the burgers too thin or wide). Place a piece of wax paper on top of each row of burgers and begin another layer of burgers on top of that.

7. The grill is ready when the coals are gray, no sooner.

8. Remove the wax paper now and place the burgers on the grill with space between each. Cooking time is about 4-8 minutes, depending on a lot of things.

9. Place the rolls in a handful of aluminum foil in a 400-degree oven until they're 2. 1 warm

> 10. Finally, turn the burgers frequently on the grill but don't try to flatten them with the things you're using to turn them. Serves 12

# New Sewage System a Must Engineer Tells City Council

New state regulations which require Lowell and all over Michigan communities to have waste treatment plants capable of removing up to 80 percent of the phosphates in the city's effluent could send tax rates soaring by 70-80 percent.

Here's the gist of a preliminary report made Monday night to the city council by Gene Roberts, a sanitary engineer for Williams & Works, Inc., a Grand Rapids firm hired to set up the program for the city.

The biggest problem the city faces, Roberts said, is that it is presently treating all the storm water and sewage that passes through its treatment plant-almost three times the normal amount for a city Lowell's size.

Unless and until the two systems are separated, the cost of treating the effluent will remain high.

Roberts told the council that his form projected a population of 3,600 by 1980 and 4,190 by 1990 and he said a system Williams & Works will present to the State Water Resources Commission next month will meet nearly all of the state's present requirements for phosphate removal for a city with Lowell's population.

"A chemical precipitation process to remove phosphates will increase the treatment plant's efficiency to such a degree that we can meet nearly all of the state's regulations for discharge into the Grand River.

"The city has got to face the possibility of tougher state restrictions," he said. "The Grand River is being more and more polluted as cities and villages expand and the state has got to issue more and more restrictions.

He told the council that a full secondary treatment system would cost the city about \$330,000 and based on present revneues, that would raise the city's resident's

sewer taxes from an average of \$25.92 a year to about \$60.

But he said that the city must first remove phosphates from the effluent to comply with state regulations, Roberts said. It will not be economical or efficient to do so until the city's storm drains and sanitary sewers are separated. After that has been done, Lowell should move toward building an adequate secondary treatment plant.

Williams & Works wants to install a 6,000-gal. chemical storage tank at the city's main pumping station. It would remove up to 80 percent of the phosphates at a cost of \$39000.

The city has drawn up plans for an ambitious storm and sewer drain separation program. It will cost the city about \$1.3 million but officials are keeping their fingers crossed for federal aid.

The plans for the two drains are under study by the State Health Department and the County Public Works Committee. City Manager Blaine Bacon said he expects work to start on the program as soon as financing can be arranged.

The preliminary reports by Roberts was approved by council and will be submitted to the State's Water Resources Commission by the end of the month for approval.
