## Area Home Ada Township Demolished in Growth Reflected in Monday's Storm Building Permits

Monday night's lightening storm com-pletely demolished a home at 6765 Four Mile Road. Mr. and Mrs. Ira Hufford and their children, Charlie Plute, second grader at Ada Elementary School, and Chuck Dyer, seventh grader at Forest Hills Junior High, were suddenly aware that their home was burning around them at 1:30 a.m. Tuesday.

According to Harry Morris Jr., fire chief of Cannon Township, there must have been material burning in the walls for some time prior to the discovery of the fire. Lightening which had struck earlier had followed the wires completely around the interior of the house. Although the fire has been listed as a

total loss by the Huffords insurance company, quick action on the part of the fire department allowed the stricken family to save a few precious keepsakes and a small amount of food.

"Our very greatest need now," said Mrs. Morris Mulder, daughter of Mrs. Hufford, "is people willing to aid in the tearing down of the remains on Saturday. Even an hour will help." The burned-out home is considered a hazard.

The family is also in dire need of cooking utensils, tableware, dishes, beds, bedding and linens. These items may be left in Lowell at this newspaper's office, 105 N. Broadway, or in the mornings at the Ada Township Hall, 555 Ada Drive. Mrs. Mulder said that clothing donations may not be needed.

Other homes struck by lightening during the storm, but not seriously damaged, were at 4670 Braeburn, 3864 Cascade Rd., both in Grand Rapids Township; and at 5951 Knapp in Ada Township.

## Building permits for Ada Township con-tinue to aid in its growth pattern.

The building inspector for Ada Town-ship, Herman Stuukie, reported at the September meeting of that governmental body, a total of ten permits issued for the preceding month. Among them were three permits for new homes and two permits for new buildings for Amway Corporation.

One of the Amway permits was issued for \$250,000 for an overhead concourse to be erected west of the present complex of buildings. It will be built by Dan Vos Construction Company over the present west driveway. The other permit issued to this corporation was for an \$825,000 addition also to be placed west of the administration building.

Fire Chief Stan Osmolenski reported seven runs in the month of August bringing the total to 69 runs for the year.

The board sent to its attorney, Gene Alkema, an ordinance for his review regarding control by the community for gatherings such as rock festivals. The ordinance was one designed for use by several western Michigan communities following the encounters at Goose Lake near Jackson.

On Thursday evening the Ada Planning Commision adopted a resolution to recommend to the board the use of the road program as indicated in the 1968 master plan by the road commission. This does not include the Leonard Street extension. A special meeting may be called by Supervisor Fred Clancey to consider the recommendation. The Kent County Road Commission is expected to take action on September

## Lowell Man in Serious Condition

A 22-year-old Lowell man was reported in serious condition by Blodgett Hospital authorities Tuesday evening as a result of a single car accident which occured Saturday night.

Melvin Byrne, of 4952 Murray Lake Ave., NE, was pinned unconscious in his car for more than two hours Saturday, Combined efforts of police, doctors, firemen and ambulance attendants were credited with saving his life.

According to Kent County Sheriff's deputies, Byrne was eastbound on M-21 about three miles east of Ada when he apparently lost control of his car, swerved across the road and rolled into a tree.

On the scene to assist with rescue operations and with routing of traffic were units from the Ada and Cascade Fire Departments, including the Cascade rescue unit, the Kent County Sheriff's Police, the Lowell Police and several ambulances. The ambulances brought blood plasma which was administered on the spot by two doctors riding with the Grand Rapids Police Department's emergency unit.

## **State Receives New Enforcement Funds**

Governor William G. Milliken has announced receipt of a 1971 advance crime control grant in the amount of \$5,989,000 from the Law Enforcement Assistance Administration of the United States Department of Justice.

This amount, added to the previous 1970 grant of \$7.8 million, brings a total of \$13,789,000 into the State of Michigan for programs involving law enforcement and criminal justice. The funds will be distributed throughout the state through the Governor's Office of Criminal Justice Programs.

The monies will be used for projects upgrading law enforcement personnel, prevention and control of juvenile delinquency, control of narcotics and dangerous drugs, reduction of organized crime, prevention and control of riots and civil disorders, increased effectiveness of correction and rehabilitation including probation and parole and the improvement of community relations.

According to the Governor, "Much is needed in this strategic area. This additional funding builds the momentum of Michigan's crime control program and serves to enhance the thrust of this most important effort. Now, with almost \$14 million available for use in 1970, Michigan can pursue major improvements in its law enforcement and criminal justice system.

## Major Crime Rises Sharply, Report Shows

Major crimes in Michigan in 1969 numbered 266,973, an increase of 50,254, or almost 23 percent, compared with 216,-713 the previous year, according to the eleventh annual "Michigan Law Enforcement Officials Report on Crime" compiled by the State Police.

This gave the state a crime rate for the year of 3075.7 major offenses per 100,000 population, an increase of 23.2 percent over the rate of 2496.7 in 1968. Major crimes on which the rate is based include homicide, rape, aggravated assault, burglary, robbery, auto theft and felonious larceny.

The report notes that the major crime total has grown from 133,528 to 266,973 in 1969, "a change of 133,445 or an alarming increase of 99.9 percent over the five year period." The percentage increase does not take into consideration the increase in the population. For 1965 data the population figure was 8.22 million, for 1969 it was 8.67 million.

Last year crimes against the person (homicide, rape, assault and robbery) totaled 40,917, up 19.9 percent from 34,129 in 1968

Crimes against property (burglary, auto theft, felonious and simple larceny) totaled 347,237, up 19.4 percent from 290,749.

Most major crimes, 74.9 percent, in Michigan were committed last year by persons under 22 years of age, the report shows. This ration of crime involvement by young people has been this high since at least 1962.


## **Rev. DeVinney to Speak** at Lowell Methodist Church






