PORTLAND, Me., Oct. 5.—A spirited discussion of the laws of C. T. U. at noon adopted, by an overwhelming majority, a memorial letter denouncing the partitioning of the National W. C. T. U. Mrs. J. Eliot Foster presided.

EVANSVILLE, Ind., Oct. 4.—The wheat transactions on the Produce Exchange during last week were unprecedented in its history. Over 20,000,000 bushels changed hands in the National W. C. T. U. of the visible supply of the United States.

CLEVELAND, O., Oct. 6.—A terrific explosion of accumulated gas occurred yesterday in the new water works tunnel in this city, and five men were terribly burned and were taken out in a dying condition.

LONDON, Oct. 7.—A dispatch from India states that a primitive expedition of British troops into Sindh engaged the natives with a loss of 2000 men, and the latter killed 400 of the British.

**POLITICAL GOSSIP.**

**Gathered from Various Quarters and Briefly Told.**

**Georgia Democrats Elect State Officers Without Opposition—The New York Mayor's Congressional Nomination—Other Notes.**

**THE FIELD OF POLITICS.**  
ATLANTA, Ga., Oct. 5.—Governor Gordon and the other State officers were elected Wednesday, there being no opposition to them. The election was quiet. The amendment to the constitution, providing for the number of Supreme Court Judges from three to five was adopted.

Up to October 1st President Cleveland had vetoed 416 pension bills, and approved 765. President Arthur approved 736 pension bills, all that passed Congress.

A UNITED STATES Senator is to be elected this winter. A Republican senate may still be necessary after election to save the country from the free trade bill. Remember this and vote for Captain Judd for Representative.

FORD'S little song: (copyrighted by the author. All rights reserved.) "Free trade in wool would raise the price of the farmer's wool. Free trade in work would lessen the cost of the workmen's woolsen clothing."

Now what can the democrats claim as their issue? The republican senate bill would "reduce the surplus and the taxes" sufficiently to revert even the worst revenue reform bowler. The only thing left them to do now is to own the corn and sugar to our own British free trade and death to American wages.

The principal difference between the Mills Bill and the Senate Tariff Bill is that the former is a Bill favoring Southern rice and sugar producers and British manufacturers, and the latter protects the American producer regardless of section, and the American manufacturer, while reducing the surplus.

A METROUIT minister in Illinois who voted four years ago for St. John has returned to the republican fold. Some of the prohibitionists asked him that stock poor of the party: "Don't you intend to vote as you pray?" His answer was: "Yes, I shall vote as I pray, but I don't intend to do any foolish prizing this year."

Free trade would place the wages of laboring men on a plane with those of the poorly-paid workmen of foreign countries. American laborers receive the highest wages in the world. Laboring men, which will you vote for, M. H. Ford and experiment with your daily bread, or vote for Belknap and the republican ticket and retain your present wages? You are asked by the democracy to exchange a certainty for a possibility, a fact for a theory. Can one of you afford to do it?

HAD it not been for the votes of Southern Brigadiers and some Northern Democrats (Ford among them) the surplus might have been reduced some twenty millions by the refunding of the State war taxes. Michigan, along with many other loyal States, paid this tax to help pay the union, and is justly entitled to being re-embursed, but Ford voted against the interests of his own State on this measure, as usual. Belknap knows enough to fight for his own State and home; he did it once among shot and shell, and he will do it in Congress too, when he gets there.
