CHICAGO, Oct 30.—After a couple of unimportant witnesses had been heard at yesterday morning's session of the Cronin trial the State called John P. WASHINGTON, NOV. L.—The report of the Government Bureau of Engraving and Printing shows that during the year there were printed United States notes, gold and silver certificates, bonds nk notes with a face value of

Chief of the Secret Service, in his an-nual report says 430 arrests were made for counterfeiting or passing counterfeit money during the year ended June 30 last. Out of 165 foreigners arrested 88 were Italians. During the year 8477,081 of counterfeit and raised notes were

captured.
Washington, Nov. 2.—The public debt statement, issued from the Treasury Department Friday, shows a reduction in the debt amounting to \$9,104,833 during the month of October. The total debt less cash in the Treasury is \$1,000,000,007, and of this amount \$100.000. 950,077, and of this amount \$852,035,173 is bonded indebtedness. The net cash or surplus in the Treasury is \$45,335,762,

or \$1,000,000 less than a month ago.

The Treasury now holds 283,539,521 standard silver dollars, \$4,834,033 silver bullion and \$2,328,873 silver certificates, bullion and \$2,328,373 silver certificates, against which there is outstanding \$277,809,844 silver certificates. The circulation of standard silver dollars has increased about \$2,500,000 the past month, and now amounts to \$39,888,480. The total coinage of the mints during October past amounted to \$6,018,153, and of this amount \$3,310,364 was in silver. \$3,570,965 in gold and \$130,622 in minor coins; 3,100,351 standard silver dollars were coined during the month.

Washinotos, Nov. 2.—Postmaster-General Wanamaker has made public an order fixing the rates for telegraphic service for the Government for the pres-ent year. The order provides that for day messages not exceeding ten body words to be sent a distance not exceeding 400 miles the rate shall be 10 cents, and 1/2 cent extra for each word in excess of ten. For a distance over 400 miles and less than 1,000 miles the rate shall be 15 cents for the first ten words, and 3/2

For a distance over 400 miles and less than 1,000 miles the rate shall be 15 cents for the first ten words, and ½ for each word in excess after. For distances over 1,000 miles ½ cent per word shall be added to the 1,000 mile rate. For night messages not exceeding twenty words the rate shall be 15 cent for all distances, and ½ cent extra for each word in excess of twenty.

A STARTLING STORY.

A Prisoner in the Winnipeg Jail Says Burke Confessed.

Cronin's Assassins Were Dan and Dennis Coughlin, Pat Cooney and Himself.

WINNIPEO, Man., Nov. I.—Assistant Bate's Attorney Baker and Lawyer Howell on Thursday secured Gillette's story of the confession about Dr. Cronin's murder, which, he says, Burke made to him while they were confined in the jail together. They had to drive out to the penitentiary to get it. Mr. Baker places considerable confidence in the story told by Gillette, and after his return made the following memorandum. of its substance:

"An nearly as I can tell the names, he said that the men who killed Dr. Cronin were himself, a Dennis and a Dan Coughlin, a Pat Cooney, and one whose name I don't remember. One man, he said who pulled out at the last minute, was a man who worked for McGinnis, a fast and oyster man out West Randolph street and the Haymarket. He did not say what weapon they need but that it was something like a clab.

"He would not say that any one struck the first blow at Dr. Cronin, but that he died hard. Dr. Cronin was a more muscular man than they ittogist he was. He said they rented the Carleon cottage and put the furniture in, but said nothing as to where the furniture came from. The corpse was taken away in an express wages which they hired from an old man on Chicago avenue. They hired it for all night, and drove it thomselves.

"They took the body down to the lake and took it out of the trunk. They said that they had expected to find a nowboat there, but there was none there and they threw the body into the water. The shore was shallow and the body showed, and the waves moved it back toward them. There was a lot of blood and a lot spilled in the sand. They used the trunk to accopt water on the body and then put the body back lato the trunk and then drove away to where they affected dumped it. WINTRY BLASTS.







To get a picture of Delphi as it was in the best days of Greece, after the building of the great temple by the Alesmonds, read the tenth book of Pausanias. He tells us of four temples in a row at the entrance to Delphi. He then describes what was to be found within the sacred precincts of Apollo: A statue of Physilus of Croton, a bull in brass by Theopropus the Æginetan, votive offering and marble statues from Teges and Lacedsmonis, a brazen horse by Antiphanis of Argos, the chariot of Amphiaraus, the horses of the Tarentines in brass, the statues of the Epigoni, the treasury of the Sicyonians, statues of Leto, and Apollo, and Artemis shooting at Tityus; treasuries of Athenians, Thebans and Syracusans, bung with the spoils of war and adorned wish statues; a pertice built by the Athenians with money which they got in war from the Peloponnesians; a brazen head of the Peconian bison, a brouze dragon offered by the Greets in common after the battle of Platea, statues of foot soldiers and cavalry by Onatas, the votive ares of Periciytus, a bronse wolf, a gilt statue of Phryne by Fraziticles toffered by herself, statues of cavalry leaders seated on horseloa, a brazen or from Eubona, a statue of Sardus, a horse offered by Callias the Athenian, a brouze statue of Homer on a pillar, the tomb of Achilles' son, the Lesche or public hall, with an enormous number of painted figures of Polygnotus and statues innumerable of Ahena and Apollo. The great temple of Apollo was adorned, as to its eastern architrave, with gilded shields from the battle of Marathon. On the pediments were statues of the gods and of the setting sun, of Hercules slaying the Lernscan hydra, Bellerophon and the Chimzera, Dionysius and a giant, etc. These ore only a small fraction of the riches of Delphi as described by Pausanias. 
