## Cub Scouts Join Fund Campaign For UNICEF

The Lowell Cub Scouts will join the Blue Birds and Campfire Girls in their "Trick or Treat" campaign for contributions to UNICEF (United Nations Children's Fund) this Saturday night, between 6 and 7 o'clock which was announced in last week's Ledger. Wearing identification tags, and carrying special cartons, the boys and girls will ask for money to help other little children throughout the world.

The UNICEF program is active in Asia, Europe, the Middle East, Latin America, and Africa. The types of aid extended vary with the country's need. Equipment and supplies for health centers are provided in many areas.

Assistance is given for the prevention and control of childhood communicable diseases, such as tuberculosis, yaws, whooping cough, and diphtheria. Milk, fish-liver oils, and other protective foods are distributed to assist child-feeding programs, with equipment being furnished to help countries conserve their local milk supply for the benefit of children.

Raw materials are supplied for clothing and shoes, and the manufacturing costs are assumed by the respective governments. Special assistance is provided for children suffering from physical or mental handicaps.

In every case, UNICEF aid is used to fill the need in such a way as to reach the largest possible number of children in ways that will be of lasting benefit to the whole structure of child health and child welfare services.

## Agree to Finish in 300 Days Let Bids for New \$300 Thousand Grade Building Monday Night

The Lowell Board of Education at an adjourned meeting on Monday night voted to award the construction of the new grade school building to the following bidders: General Construction, Beckering Construction Co. of Grand Rapids for \$190,400; plumbing and heating Holwerda-Huizenga Co. of Grand Rapids for \$67,690; and the electrical contract was let to Hertel Electric Co. of Grand Rapids for \$22,815.

All three bids were accepted less deductions authorized by the board.

The total savings in the deductions authorized by the Board of Education will be about \$12,000 these were merely minor changes that were found to save money without eliminating any essentials from the building.

Total Cost \$268,000  
The total cost of these three items of construction will be approximately \$268,000 which is some \$18 thousand more than the bond issue of \$250 thousand. This additional money will come from funds from the last installment of the 5-mill levy for the building and site fund.

An additional \$42 thousand will be needed to pay architect and attorney fees, provide furnishings for the building and properly equip the kitchen and all purpose room. This is expected to bring the total cost of the new school to \$312,000. A large portion of this excess over the bond issue will have to be made up from other school revenues.

There were nine bidders for the general construction the high bid was \$230,000; there were 8 bidders on the plumbing and heating and the high bid was \$78,815; there were only 5 bidders on the electrical construction; the low bidder was disqualified for not bidding the correct specifications, the high bid was \$29,000.

Contracts will be signed this week and the general contractor has agreed to build the school within 300 days which will permit the use of the building for school next fall.

## Vaccine Available For Children From Ages 5 to 9

If you have a child in the five to nine year range, "right now" is an ideal time to see to it that he gets the new polio vaccine, the Michigan Department of Health urged this week.

Dr. Albert E. Heustis, State Health Commissioner, said local health departments have vaccine on hand for five through nine-year-old youngsters.

Large numbers should be vaccinated without delay," Dr. Heustis said, as this is the best time to start immunization which will give protection against paralytic polio next year.

### Available Here

Doctors in Lowell have enough vaccine available to them to handle the Lowell trade-area children in the designated group, and hope to be able to expand this program to children from one through 14 years, and also pregnant women, in the very near future.

Local doctors estimate they have already given the shots to about 100 of the potential 250 children in the 5-6 year group of this locality, in clinics held during the past two weeks. The vaccine is supplied free, with only the cost of office expense being made by the family physician.

Dr. R. E. Regan and C. A. Mapes, leaders in the Lowell Village-Township United Red Feather-Red Cross drive for funds stated Wednesday morning their total collections had reached 95 per cent of the goal set for them.

The collections of \$5,044.92 were \$242 short but both men stated they were confident the people of Lowell village and township would not let them down in the closing hours of the campaign.

The drive ends tonight (Thursday), and not only provides funds to aid in Red Cross and County projects for the welfare of the needy, but will return funds to our own community for important civic projects.

## Over \$5,000 Damage To Francisco Home In Fire Tuesday

The Home of Mrs. Clyde Francisco on Five Mile rd. near Lincoln Lake rd. was damaged to the extent of \$5,000 to \$6,000 by fire Tuesday night, according to an estimate of Lowell fire chief Frank Baker. The alarm was sounded about 7 o'clock in the evening when the smell of smoke revealed a first-floor closet close to the chimney to be aflame.

The Lowell department was the first to arrive at the scene and had the fire almost under control when their water supply ran out, and it was not until the Vergennes department wagon arrived that the blaze could be extinguished. Grattan fire department also answered the alarm.

Although the fire was confined to the closet and one room, the rest of the 7-room house was badly damaged by smoke. Firemen were hampered in fighting the fire because of a large collection of paper and quilting materials, etc., stored in the closet and room.

Willard Dennick, a Lowell fireman, was hurt while fighting the fire at the Francisco home. He suffered two cracked ribs when hit by the nozzle of a fire hose while in a smoke-filled room.





Little known, yet a vital element of our democratic process! I am referring to the consent calendar in the consideration of which your Congressman participated during the last session of Congress.

Three Republicans and three Democrat Members of Congress are selected by their respective House party leaders to serve as "official objectors" on the consent calendar. In 1950 your Congressman was first appointed an "official objector" by the Republican leadership in the House. I have continued in that capacity during the 84th Congress.

The consent calendar is adapted only to legislation which is not expected to become controversial or draw political lines. After legislation of this kind has been reported from a committee, the chairman may request that it be placed on the consent calendar, I was on the consent calendar dealing with public bills. There is also a consent calendar for private bills. On the first and third Mondays of each month these bills come up before the House for unanimous approval. But prior to this, I would receive along with the other members of the objectors of the consent calendar, the legislation recommended by the various committees with an analysis of each bill.

Now after visiting 22 communities of Kent and Ottawa Counties in my "Mobile Office" I feel this project has been extremely successful. With only two exceptions, and those very brief, I have been occupied constantly by local residents coming to this "office."

So far I have met and talked privately with approximately 800 persons in this manner. Later I will report to you more fully on the results from my "Mobile Office" tour.

Streamlining Government

During the first three years of the present Administration, the Federal government spent \$36 billion less than it would have, had the "spendthrift" policies of the preceding administration continued. This sum represents a saving of nearly \$1,000 for every family of four in the United States.

The Republican trend toward streamlining government has been apparent in all branches and agencies. For instance, the Army's standardization of tank parts will save taxpayers \$560,000,000 during the next 10 years. And the Bureau of Engraving has cut operating expenses by an estimated \$1,350,000 a year starting this November 1 through improving methods and modernizing equipment. The Department of Defense recently announced that through the sale of surplus, obsolete and worn-out materials in the fiscal year 1955, it was able to collect \$143 million. This represents the highest percentage return on these sales in four years.

Remodeling the Capitol

Last year Congress appropriated \$5 million in the first move to give our United States Capitol Building a face-lifting. And each successive session of Congress can be expected to make additional appropriations until the work is completed. The last major construction work on the Capitol was completed in 1865. Ever since then Capitol architects have recognized the need to correct the architectural defect which has placed the Dome off center and too near the Capitol's front side. Present plans call for a 40-foot extension of the front or east side to correct this long-stranding architectural fault.

These same plans make provision for a more substantial central portion to reface the sandstone structure which has been there since the cornerstone was laid in 1793. Also, the addition will make space available for much needed office quarters, committee rooms and restaurant facilities.




