Lowell Rejects Welfare Relief Proposal

Few Turn Out For Tuesday Primary

Lowell voters rejected the Welfare Relief Bill at the Primary Election Tuesday when a handful of peo- Stephen Nisbet Confers ple turned out at the polls. Proposal No. 1, which With School Principals would have increased taxes one and one-half mills, was turned down 197 to 173, although Proposal No. 2, to enforce it, was accepted 175 to 169. Only 388 votes were cast in Lowell Township, compared to 1,-914 who were registered. This was one of the smallest turnouts proportionately of all townships in this area. On the Kent County level, the welfare measures were defeated on both counts: 15,622 to 13,312 on the first proposal; 14,532 to 12,164 on the second.

New Point System

One of the most widely publicized changes in the Michigan Ve nicle code is an amendment to section 320 which provides that the issioner (director of motor vehicle services in the secretary of may after a re-examination recommend to the partment the suspension or revocation of the license of a person who has charged against him within a period of two years a total of 12 or more points as provided in a further addition to the code.

The new section, 320a, creates a point system to be used for the purpose of determining the record of a motorist according to the folowing formula:

(a) Manslaughter, negligent homicide or felony resulting from peration of a motor vehicle-6 points. (b) Operating a motor vehicle while under the influence of in-

xicating liquor or narcotic drug-6 points. (c) Failing to stop and disclose identity at the scene of the ac-

dent when required by law-6 points, (d) Reckless operation in violation of section 626 of the motor acts as amended or a similar violation under the laws of any other

state or municipality within or without the state of Michigan-6 points. (e) Violation of any law or ordinance pertaining to speed by exeeding the lawful maximum by 15 miles per hour or more-4 points.

(f) Violation of any law or ordinance pertaining to speed by exeeding the lawful maximum by less than 15 miles per hour-3 points. (g) Disobeying a traffic signal, stop sign or improper passing--


