## Lowell Area School to Offer Plan For Elementary Building in Alto Community

Monday evening the Lowell Area School Board authorized Superintendent Stephen Nisbet to procure preliminary plans for architects, Campau and Crowe, for an elementary school in the Alto area, Harold Metternick of the Alto School Board was in attendance at the meeting and asked that the Lowell Board's plans were for the area around Alto if those districts should join the Lowell district.

The board pointed out that any building would have to be voted by the people of the district but the board was favorable to establishing a school with kindergarten through sixth grade in Alto.

This would serve the entire area south of the new freeway with only the 7 through 12 graders being transported to Lowell.

The entire plan would of course, be subject to enough of the districts voting to join Lowell. The building could be built next year if the area decides to become a

part of the district. In the meantime the board urged Metternick to look for a site in Alto that would be suitable and the projected plans would be ordered.

The superintendent reported to the board that Fallsburg district will vote August 16 on joining Lowell. The Wilkinson district being served by Lowell will send their 7th and 8th graders to Lowell this year.

**Order Work On Schools**  
The board was told that the conversion from oil to gas heat for the Runciman elementary building has been completed and the water heating equipment was also being changed over to gas.

The sidewalk and curbing work on Washington street were ordered, also the filling in of the school grounds to raise this above the water level of the river. Enough chain link fence has been salvaged from the local school and from some annexed districts to install this along the sidelines of the football playing field.

**Need Teachers**  
Superintendent Nisbet revealed to the board that a kindergarten, fourth and fifth grade teacher are needed. Don Kelly the former shop teacher has been employed to teach in the 8th grade for the coming year; also Jack Kempker in the 6th grade.

It was announced that Mrs. Eitelbus has resigned as kindergarten teacher. She plans on teaching in Holt this coming year. Mrs. Higbee an elementary teacher signed up this spring has also resigned.

**Bus Drivers**  
Only two ladies have responded to the call for bus drivers. If they qualify they will be employed to assist this year although several more are needed.

There is still time for other ladies to apply if they are interested.

### Bookstore Hours

The bookstore will be open between the hours of 9-12 and 1-4 during the weeks of August 15 and August 29. Books will be on sale for grades 7-12. Books for grades 1-6 are on a rental basis, prices to be announced before the opening of school.

## Annexation Vote For Fallsburg Coming August 16

The Fallsburg school district, Vergennes 1 Fr., will hold a special meeting Tuesday, August 16, at the school building for the purpose of voting on the proposal of annexing to the Lowell Area Schools. The special meeting will begin at 8 p. m.

At their annual meeting the Fallsburg school board was instructed to ask the Lowell board for a resolution to offer them the opportunity to annex. This resolution was adopted at the July 11 meeting and sent to the Department of Public Instruction in Lansing for approval.

**Annexation Logical**  
Fallsburg school would have only eight children for the coming year and at the annual meeting it was therefore thought to be impractical to operate. The services of a teacher had not been contracted for at that time.

The school census showed that there would be no children coming into the lower grades for the next school year to qualify for state aid. This also helped to make the decision to ask for annexation logical at this time.

The record shows that the Lowell board of education often gives aid through annexation to those rural school districts which find it to their advantage.

It is expected that other districts will be discussing annexation soon. Logan and Talbot school districts have voted to send in their seventh and eighth grade students for the coming year.

Superintendent Stephen Nisbet announced this week that the Lowell high school principal's office will be open August 15 and 16 for the purpose of enrolling students who will be new to the school system during the coming year.

Carl Hagen will be in his office from 9-12 and from 1-5 to enroll all grades. Those students who enrolled during Rural Day last spring need not report at this time.

Mrs. Noah, the school nurse, will also be on hand to secure health records and to hand out health forms which are to be filled in by family doctors before a child is enrolled in kindergarten.

**Polio Shots Needed**  
Parents of kindergarten-age children are reminded that the state law requires a student to be five years old on or before December 1, 1960, and that he have his polio and immunization shots before enrolling.

## Turning Back the Clock... Old, Miniature Press Comes to Light

Now on display in the front window of the Ledger office, the little hand-operated press is estimated to be over 100 years old and is similar in operation to a large Kluge-rebuilt Chandler-Price machine used by the Ledger staff for job-printing. The press is still in operating condition, but lacks the rollers which pass over the type faces after receiving ink from the round ink plate. Not a toy but a scaled-down working model, the press was probably used for printing business cards and small letterheads.

## News of Exchange Students Droogers Hear From Peter Kahle

Mr. and Mrs. James Drooger of North James Street, Lowell, recently received several letters from Peter Kahle, Lowell's 1959-60 exchange student from Bremerhaven, Germany, who made his home with the Droogers while in this country.

Peter reached his home on Sunday, July 24, after leaving Montreal July 15 aboard the QSS Arkadia, a Greek ship. This was the same ship which brought him to this country only a year ago this month.

Peter reported that, while on board the ship, he taught advanced German on a very small scale and thus earned himself an invitation to a party given by the captain of the vessel.

"For our arrival in Bremerhaven again we had wonderful sunshine, and, seeing the parents on the dockside, one was somewhat glad to be home again, especially as they made a point out of it to 'spoil me as much as possible'."

"Back at the 'Crown Drug' we had a real good dinner and I was shown my room, to which Mother had done wonders. But although the surroundings are familiar, it will take some time until I feel myself as much at home as before. My mother was really shocked about that haircut, as she had planned to be. But today she already said that she would try to get used to it and that it actually didn't look that bad. 'Father moaned only, 'Completely Americanized!'"

**Difference in Drivers**  
Peter went on to say that "My American driver's license isn't of much value here in Germany, unless I drive a car with American license plates. So I am going to theoretical instruction lessons now, four days a week for three weeks, two to three hours each time."

"The funny thing: in those darn U. S. you have less training, less regulations, less signs—and better traffic discipline!"

Mrs. Drooger explained that Peter always felt our highways were extremely well marked, and that American drivers were always very polite. He once told the Droogers that if you see a polite driver in Germany he is probably an American serviceman, as they have a very fine reputation there.

**Counselors Needed**  
Peter also mentioned that a Mr. and Mrs. Kynast of Saginaw were two of the counselors aboard the Arkadia during his trip home. They were traveling to Germany to accompany the new exchange students for the coming year to the U. S.

Peter spent his first week in this country with the Kynasts before arriving in Lowell, Mr. and Mrs. Kynast have been in the exchange program 5 years, having opened their home to 4 students, and they work as counselors throughout the year.

Peter stated that the Michigan Council of Churches, which sponsored his trip here, is desperately in need of more counselors to call on students staying in Michigan and to visit and counsel their American "parents."

The Kynasts were guests at the Kahle home in Bremerhaven, according to a letter which the Droogers received from Peter's mother. The Kahles greatly appreciated the opportunity to find out more about the program.

Vegetables Like Kind Cooks, Say U-M Dietitians

Vegetables contain helpful nutrients, but boiling dissolves many of these vitamins and minerals into the water. They escape from all the cooking process, the more water-soluble vitamins and minerals are lost.

Therefore, say dietitians at the University of Michigan Medical Center, you should observe these cautions when cooking vegetables:

1. Use just enough water to prevent scorching;

2. Add the vegetables to boiling water in order to reduce the total time in the water;

3. Cook until just tender in a tightly covered pan.

An exception is made for green vegetables. They tend to discolor when cooked in a pan that is tightly covered. So leave the cover off the first few minutes. This permits the escape of the volatile acids which cause this discoloration, say the U-M food specialists.

The amount of four-ounce divided highway in Michigan—express way and non-express-way—has at least doubled in less than three years, from 489 miles on July 1, 1957, to 883 miles today.

**It's Up to Homemakers To Guard the Food**

Your eyes and taste buds don't always warn you of food poisoning. Mary C. Coleman, instructor of foods and nutrition at Michigan State University, says a food may taste and look good yet still be the source of serious digestive upsets.

Most food spoilage is apt to occur after the food leaves the grocery store. This places the responsibility of preventing food contamination on the homemaker.

Bacteria capable of poisoning food prefers warm, moist protein foods and mixtures containing milk, eggs, meat, poultry or cheese are susceptible. About three and a half hours is the safety period for these foods if they are not refrigerated. When you place large amounts of warm food in the refrigerator, use shallow pans to promote quicker cooling of the food.

Refrigerate protein foods as soon after preparation as possible and put leftover meats and poultry in the refrigerator right after the meal. Keep the food preparation area and utensils very clean. Before you use a food, be sure to clean it well, especially foods to be eaten raw.

When canning, says Miss Coleman, use the pressure cooker to preserve non-acid foods such as meats and vegetables. The one very serious type of food poisoning, often fatal, is botulism which develops in improperly home-canned, non-acid foods.

According to James M. Hare, chairman of the Michigan State Safety Commission, both rural and urban areas showed substantial increases in injuries and deaths last year.

Michigan State Police reports show that rural areas still account for 7 out of 10 highway deaths but show that injuries in city areas were up 14 per cent last year compared to 9 per cent for rural areas.

"It looks as though we will have to concentrate harder than ever on the three E's of highway safety," Hare said. "With a sound program of Education, Enforcement, and Engineering going on in each county we should soon be able to bend the death and accident trend downward."
