

Awarded ROTC AF scholarship

ments as well as competing against thousands of other candidates on a nation wide basis, Cadet Boyd was among 1,000 selected from 180 of the nation's top universities and colleges.

Activation of his scholarship commenced with the beginning of the fall term at the Michigan Technological University in Houghton where he will major in Chemistry.
