The two newly elected mem-bers of the Lowell Area School Board, William Jones and Gould Rivette, expressed their conpart of the board cern over the loss of the 7 mill operating levy Tuesday, but said they had confidence in a second vote passing. In a statement on Tuesday

the board members-elect said hey felt the board should call for a new vote on operating millage immediately. They did not reveal whether they felt that the board should come back with the same 7 mill proposal or to shave operating costs enough to cut back one or two mills

The proposal to levy seven mills operating tax for the next three years was defeated by 24. votes; with 574 taxpayers vot-

ing yes and 598 voting no. The third proposal on the ballot, to give all board members a \$100 yearly salary, the voters gave their approval—749 yes to 420 no.

#### Board to Meet ,

The Board recessed their meeting, following the tabula-tion of votes Monday evening, and will reconvene Thursday at 7:30, when they will receive an austerity program of operation from Supt. James Pace. Pace said on Tuesday that he would not propose calling another vote on extra millage this year, but would cut the school operation down to what the taxpayers voted for on Monday. If the millage was defeated, Pace pointed out in an earlier letter to the Board, the school
